LMT Lenten Fish Fries Return for 11th Year

Our popular Lenten Fish Fries are returning to our Lakewood Masonic Temple for an eleventh season, much to the delight of our loyal following. Organized by and, for the ten first years, chaired by our Wor. Bro. Bert Horne, our Fish Fries have grown increasingly popular each year.

Our 2025 Fish Fries are scheduled every Friday during Lent starting on March 7 and running through Good Friday, April 18, serving from 4:30p to 7:30p. Cash, credit/debit cards and tap-to-pay devices are accepted forms of payment.

Customers have the option of dining in or carryout. Those dining in can enjoy our traditional live entertainment, an open mic event organized by our Bro. Gary "Guitar Guy" Rice, who is noted especially for writing his interesting and entertaining guitar and music themed columns and for his experience restoring guitars for Cleveland's Rock & Roll Hall of Fame.

This year's adult meals offer the option of beer battered cod or potato cheddar pierogis and include a choice of two side dishes and a beverage, all for the cost of \$17 per person. A children's meal is available for \$8 per child including a choice of two side dishes and a beverage. Our popular side dishes include cole slaw, French fries, New England clam chowder, cabbage & noodles, mac & cheese, pierogis, fish and dessert. Side dishes can be ordered by themselves (a la carte) or as additions to the meal at a cost of \$3 each.

We also have an ample supply of free parking accessed from Andrews Avenue, adjacent to our side door entrance.

Proceeds from our Lenten Fish Fries ultimately help support and maintain our historic Lakewood Masonic Temple and preserve it for future generations. Come and visit us in the heart of the Downtown Lakewood Historic District.

New Ways to Donate to our Foundation

Starting in 2023, holders of traditional (not Roth) IRAs must begin taking required minimum distributions (RMDs) in the year they turn age 73. Distributions made directly from an IRA to a qualified charity such as

our Lakewood Masonic Foundation can count toward your required minimum distribution, subject to a collective limit of \$100,000 per year. Such distributions do not incur either federal income or estate taxes but also do not count as itemized deductions for tax purposes.



Donations can be made after death by naming The Lakewood Masonic Foundation as a beneficiary in your will, life insurance policy, IRA, TOD (Transfer on Death) account or the like, either as a fixed amount or a percentage. Gifts may be in the form of cash, securities or property. Gifts of appreciated securities and/or charitable gift annuities can be especially beneficial to the donor. In matters such

“Operative Fraternity of Masons”

“The Worshipful Society of Free Masons, Rough Masons, Wallers, Slaters, Paviers, Plaisterers, and Bricklayers” is a flourishing and influential society of operative Masons in Great Britain which admits members by rites of initiation and divides them into degrees. It has been introduced into the circles of discussion in Masonic Research Societies by Bros. Dr. Thomas Carr and by C. E. Stretton, and in the American Fraternity has been popularized by *Guild Masonry in the Making*, by Bro. Charles H. Merz. One of the most scholarly works on it is *The Builders’ History*, by R. W. Postgate; London; 1923. According to the traditions of the Society Dr. James Anderson began as an Operative Mason, was expelled, and in 1714 began to “make” non-Operatives, among them Payne, Entick, Montague, Desaguliers, etc.; and it was in this wise, so they argue, that Speculative Freemasonry was begun. This theory is contradicted by so many known facts (and of which there are many written records) that scholars cannot take it seriously; it contradicts, for example, the fact that the first Grand Lodge was started not by Anderson and Desaguliers but by Antiquity Lodge and three other Lodges much older than 1717 (of 1714); that Lodge Minutes record Accepted non-Operative members as early as 1640 (*circa*); that No. 4, one of the Time Immemorial Lodges, was composed wholly of Speculatives *before* the Grand Lodge was erected; etc.

Out of the general operative masonry (building, architecture) in Europe and Great Britain for a thousand years or so a number of separate movements, societies, organizations developed, and our own Speculative Freemasonry was only one among many of these. There were separate and independent Lodges, some wholly Speculative and some wholly Operative (St. Johns’ Lodges) which did not affiliate with any general society; there were the City Companies; there was the Compagnonnage in France, and the Steinmetzen in German; there were at least two Worshipful Societies of Operative Masons; there were a number of architectural clubs (*dilettanti*); etc., etc. In some of these, old Masonic customs, rites, symbols, and rules were perpetuated, but the fact does not mean that they were “older” than Speculative Freemasonry, still less that they were its originators. Mr. Postgate, whose book is faithful to the canons of scholarship and historical criticism (as many writings on the subject are not), believes that there was a Worshipful Society of Operative Masons in London after the fire of 1666, but that it disappeared; and he believes that the Operative Society now in existence dates no farther back than the early decades of the Nineteenth Century, a hundred years after the first Speculative Grand Lodge.

In Scotland Operative Lodges and Speculative Lodges both sought Charters from the Grand Lodge, and in so doing occasioned so much

Easter

Easter Sunday, being the day celebrated by the Christian church in commemoration of the resurrection of the Lord Jesus, is appropriately kept as a feast day by Rose Croix Freemasons.

The Western churches, or those not identified with the Jewish race, generally keep Easter as the first day of the Holy Week following the Friday of the crucifixion, while the Eastern churches as a rule keep Easter as the fourteenth day of April, immediately following the general fast. With the Jews, the Christian thought of Easter bears significant resemblance to the Paschal Lamb. Easter signifies to the entire Western Christian world the resurrection of the Christ, the name being derived from the Latin *pascha* which, in turn, came from the Chaldee or Aramaean form for the Hebrew word meaning *Passover* (see Exodus, xii, 27).

According to Bede the name is derived from *Eostre* or *Ostara*, the name of the Anglo-Saxon goddess of spring. *Eostur-monath* or our month of April was also dedicated to this goddess. The German name for Easter is *Ostern*, named after this self-same goddess of Spring, the Teutonic *Ostera*. The New Testament makes no mention of an observance of Easter. The first Christians did not have special days held more sanctified than the rest. As has been written (*Ecclesiastical History*, Socrates v, 22), "The apostles had no thought of appointing festival days, but of promoting a life of blamelessness and piety."

For centuries the controversy as to just exactly what day was to be held as Easter went on between the various sects. Easter day is, briefly, the first Sunday after the full moon following the vernal equinox. This varies in different longitudes and this difficulty presented many problems to the clergy and the astronomers. About the year 325 it was decided by the Council of Nicaea, called by Constantine, that the correct date of Easter was to be reckoned at Alexandria and announced each year to the churches under the jurisdiction of that See by the Bishop himself. This was to be communicated

Nebuchadnezzar

About 630 years before Christ, the Empire and City of Babylon were conquered by Nebuchadnezzar, the King of the Chaldeans, a nomadic race, who, descending from their homes in the Caucasian Mountains, had overwhelmed the countries of Southern Asia. Nebuchadnezzar was engaged during his whole reign in wars of conquest. Among other nations which fell beneath his victorious arms was Judea, whose King, Jehoichin, ascended the Jewish throne. After a reign of three years, he was deposed by Nebuchadnezzar, and his kingdom given to his uncle, Zedekiah, a monarch distinguished for his vices. Having repeatedly rebelled against the Babylonian king, Nebuchadnezzar repaired to Jerusalem, and, after a siege of eighteen months, reduced it. The city was leveled with the ground, the Temple pilaged and burned, and the inhabitants carried captive to Babylon. These events are commemorated in the first section of the English and American Royal Arch system.

confusion, even after 1800, that the Grand Lodge had to clear it up by special legislation. In one case a Lodge was in reality *two* Lodges, one section being Operative, the other Speculative.

to the Roman See. A bitter controversy ensued. Many refused to accept this solution of the difficulty, insisting upon the observance of the fourteenth day. Attempts were made to compute by means of cycles of years the correct time. At first an eight years’ cycle was adopted, then the eighty-four year cycle of the Jews, and after much reckoning a cycle of nineteen years was accepted.

Owing to the lack of anything definite Saint Augustine tells us that in the year 387 Easter was kept on March 21 by the churches of Gaul, on April 18 in Italy and on April 25 in Egypt. The ancient Celtic and British Churches adhered stubbornly to the finding of the Council of Constantine and received their instructions from the Holy See at Rome. Saint Augustine of Canterbury led the opposing group and this difference of opinion had the effect in England of a Church holding East on one day of certain years and the other Church holding Easter on an entirely different Sunday. Bede tells us that between the years 645 and 651 Queen Eanfleda fasted and kept Palm Sunday while her husband, Oswy, then King of Northumbria, followed the rule of the British Church and celebrated the Easter festival.

In 669 this difference of opinion was ended in England, due probably to the efforts of Archbishop Theodore. In 1752 the Gregorian reformation of the calendar was adopted by Great Britain and Ireland. Easter at present is the first Sunday after the full moon which happens upon or next after the 21st of March, and if the full moon happens on a Sunday, Easter-day is the Sunday after. By *full moon* is meant, the fourteenth day of the moon.
